The Mayor and Council of the City of Fort Valley held a called meeting on Wednesday, January 10, 2018, at 1:00 p.m. at City Hall.

Mayor Williams stated that Councilwoman Juanita Bryant is absent. However, she gave her opinion on yesterday that she would be in favor of giving the money for the rings. Mayor Williams also stated that Council Marvin Crafter called her and told her that he would not be attending the meeting.

 - i. Chief Spurgeon stated that the last time we paid it was almost \$10,000.
- d. I stated to them that the money needed to be given to the Peach County Board of Education in order for it to be a legal contribution. Earmarking for the rings may not be legal since we have to give for educational purposes.
- e. There was more discussion regarding how to proceed with giving the money.
- f. Mayor Williams stated that If you are in favor of the contribution of \$5,000.00 to the board of education to the athletic program... someone needs to make a motion
- g. Councilman Juanita Bryant motioned to give the BOE \$5,000.00 for the purchase of rings
